Reuse of PPE is not recommended then how we are using the same white coat for many days' using without washing.<sup>[4]</sup>

To prevent this situation, we have suggestions that can help;

- 1) Students can keep their white coats in medical schools. They have to wear it only when clinical practice and not the whole day in school.
- 2) Separate white coat or another apron-type disposable material provided by the school to attend the clinical practice class, which they have to remove and dispose of after class completion.
- 3) White coat is used as protection from infections. Complete banning of white coats into theory class, canteen, and other places where no chance of exposure to infection.
- 4) Many students have only one white coat. Due to this reason, they wear a white coat all weekdays, and they wash it on weekends. Two or more white coats can be provided by medical schools will be helpful in prevention. Many hospitals provide washing facilities for staff aprons. If a medical school or their hostel provide a washing facility with disinfection for student white coat, it will help to prevent the infection-causing white coat.
- 5) Last but not least, performing hand hygiene during the clinical practice as and when required. [5]

Several institutes are implementing one or more suggestions in their institute as a part of institutional discipline and infection control. These suggestions are not easy to implement and need more effort as well as a cost, but without effort, nothing will be achievable.
